**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY
BATONG MALAKE, LOS BAÑOS, LAGUNA AMOUNTING TO ONE MILLION
FOUR HUNDRED FIFTY SEVEN THOUSAND FORTY-EIGHT PESOS AND 29/100
(P1,457,048.29) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA,
in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of
Barangay Batong Malake, Los Baños, Laguna in the amount of One
Million Four Hundred Fifty Seven Thousand and Forty-Eight Pesos and
29/100 (P1,457,048.29) for fiscal year 2019.

- SECTION 2. COVERAGE – The amount of One Million Four Hundred Fifty Seven Thousand and Forty-Eight Pesos and 20/100 (P1,457,048.29) shall cover the expenses for MOOE: Office Supplies – P100,000.00, Training Expenses – P300,000.00, Prizes – P60,000.00, Representation Expenses – P30,000.00, Drugs and Medicines (Free Anti-Rabbies Vaccination) – P50,000.00; PS: Barangay Clerk – P43,050.00, Garbage Collector – P36,972.00, Communication Equipment Technician – P54,000.00, Barangay Utility – P129,150.00, Task Force Kalinisan – P61,320.00, Barangay Justice – P30,792.00, Other Personnel Benefits (Medical Assistance) – P10,000.00; BDF: Water Supply System (Rehabilitation of Open Canal – Banahaw St.) – P208,111.09, Other Infrastructure Asset (Construction of Concrete Pavement-Multi-Purpose Hall Front) – P343,653.20.
- SECTION 3. SOURCE OF FUNDS – The amount of One Million Four Hundred Fifty Seven Thousand and Forty-Eight Pesos and 29/100 (P1,457,048.29) of Barangay Batong Malake shall be sourced from the Beginning Balance – P1,457,048.29.
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.
- SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
