**ORDINANCE NO. 2019-1848**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY  
TUNTUNGIN-PUTHO, LOS BAÑOS, LAGUNA AMOUNTING TO FOUR HUNDRED  
THOUSAND PESOS (P400,000.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA,  
in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Tuntungin-Putho, Los Baños, Laguna in the amount of Four Hundred Thousand Pesos (P400,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of Four Hundred Thousand Pesos (P400,000.00) shall cover the expenses for MOOE: Fuel, Oil, Lubricants Expenses – P200,000.00, Electricity/Streetlight – P100,000.00, Repair of Motor Vehicle – P50,000.00, Office Supplies – P40,000.00 and Accountable Forms – P10,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Thousand Pesos (P400,000.00) of Barangay Tuntungin-Putho shall be sourced from the Beginning Balance – P400,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
