**ORDINANCE NO. 2019-1849**

**AN ORDINANCE TRANSFERRING THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) FROM THE UNEXPENDED BALANCE FOR PERSONAL SERVICES (OVERTIME PAY OF MUNICIPAL PERSONNEL) DURING THE CONDUCT OF THE MAY 13, 2019 MID-TERM ELECTIONS TO MAINTENANCE AND OTHER OPERATING EXPENSE (MOOE) IN PREPARATION FOR THE 2020 BARANGAY ELECTION UNDER THE 2019 ANNUAL BUDGET ELECTION RESERVE OF THE MUNICIPALITY OF LOS BAÑOS.**

WHEREAS, the Local Government Unit of Los Baños has allocated funds to cover personal services and maintenance and other operating expenses for the conduct of the May 13, 2019 Mid-Term Election under the 2019 Annual Budget;

WHEREAS, after payment of expenses incurred during the election, as unexpended balance was left under personal services;

WHEREAS, the Commission on Elections calendar of activities for the ensuing year include the conduct of the 2020 Barangay Elections;

WHEREAS, COMELEC announced that registration of voters will resume on August 1 until September 30, 2019 and sought the assistance of the municipal government for information dissemination;

NOW THEREFORE, on motion of Councilor Geronimo A. Ciceron, duly seconded by Councilwoman Josephine S. Evangelista and Councilor Janos S. Lapid and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. The amount of One Hundred Thousand Pesos (P100,000.00) be transferred from Personal Services (PS) to Maintenance and Other Operating Expenses (MMOE) under the Election Reserve in the 2019 Annual Budget.

SECTION 2. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
