**ORDINANCE NO. 2019-1851**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY MALINTA, LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED SIXTY THREE THOUSAND EIGHT HUNDRED SIXTY PESOS (P163,860.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Malinta, Los Baños, Laguna in the amount of One Hundred Sixty Three Thousand Eight Hundred Sixty Pesos (P163,860.00) for fiscal year 2019.

SECTION 2. COVERAGE – The amount of One Hundred Sixty Three Thousand Eighty Hundred Sixty Pesos (P163,860.00) shall cover the expenses for PS: Honoraria Adjustment-BPSO (20) – P143,550.00, Dumptruck Driver – P2,364.00, Utility Worker (3) – P12,197.70, Lupon Tagapamayapa – P5,748.30.


SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Sixty Three Thousand Eight Hundred Sixty Pesos (P163,860.00) of Barangay Malinta shall be sourced from the Beginning Balance (General Fund)– P133,392.00; Realignment/Reversion: PS Savings (Jan.-June 2019): BPSO (1,271.00x3x6 months) – P22,878.00, Sports Coordinator (1,265.00x6 months) – P7,590.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


