ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY SAN ANTONIO, LOS BAÑOS, LAGUNA AMOUNTING TO THREE HUNDRED THOUSAND PESOS (P300,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay San Antonio, Los Baños, Laguna in the amount of Three Hundred Thousand Pesos (P300,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of Three Hundred Thousand Pesos (P300,000.00) shall cover the expenses for General Fund - 404th Founding Anniversay Celebration/18th Batiwag Festival – P45,000.00: (Barangay Night – P20,000.00); Barangay Booth (P15,000.00); Civic

Parade (P10,000.00); Fidelity Bond Premiums – P8,000.00, Fuel, Lubricant and Oil Expenses – P30,000.00, Telephone Expenses – P25,000.00, Common Office Supplies – P30,000.00, Other Supplies/Materials – P45,000.00, Electricity Expenses (Barangay Hall) – P35,000.00; Repair and Maintenance: Machinery and Equipment – P40,000.00, Building and Other Structure – P15,000.00, Furniture and Fixture – P10,000.00 and Transportation Equipment – P17,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Thousand Pesos (P300,000.00) of Barangay San Antonio shall be sourced from the Beginning Balance (General Fund) – P300,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


