AN ORDINANCE REVERTING THE AMOUNT OF THREE HUNDRED FIFTY THOUSAND PESOS (P350,000.00) FROM CAPITAL OUTLAY (ACQUISITION OF MUSICAL INSTRUMENTS) TO MAINTENANCE AND OTHER OPERATING EXPENSES (PROCUREMENT OF BAND UNIFORM) UNDER THE CONTINUING APPROPRIATION AND FURTHER APPROVING THE SAME.

WHEREAS, the 2019 Annual Budget of Los Baños embodied the priority program, projects and activities for the current year with fund allocation utilizing the town's scarce resources for the general welfare of the people;

WHEREAS, other funding needs for program and project implementation are supported by supplemental budgets undertaken immediately upon availability of funds or specific budget allocation are continued for the purpose after the closing of books at the end of every year;

WHEREAS, the Los Baños Municipal Brass Band, composed of students from various public and private elementary, junior and senior high school students, out-of-school and working youth of the town, number to eighty (80) was organized primarily to enhance their skills on playing musical instruments, deviate their attention from illegal activities and other social menace and pave the way for scholastic opportunities;

WHEREAS, the Los Baños Municipal Brass Band subsist through financial assistance from the private sector and the municipal government;

NOW THEREFORE, on motion of Councilor Mike Dexter A. Concio, duly seconded by Councilors Geronimo A. Ciceron and Cris Dayril B. Bagnes and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


SECTION 1. The amount of Three Hundred Fifty Thousand Pesos (P350,000.00) be transferred from Capital Outlay (CO) to Maintenance and Other Operating Expenses (MOOE) under the Continuing Appropriations for the procurement of band uniform.

SECTION 2. The source of fund shall be taken from the reversion of funds from Capital Outlay (acquisition of musical instruments) to MOOE under continuing appropriations.

SECTION 3. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
