ORDINANCE NO. 2019-1860

ORDINANCE CREATING THE LOS BAÑOS SPORTS COUNCIL, UNDER THE LOCAL YOUTH DEVELOPMENT OFFICE (LYDO); DEFINING ITS FUNCTIONS AND PROVIDING SUBSEQUENT FUNDS THEREOF.

WHEREAS, Sports Program plays vital part in the development of our youths, aside from academics, it is, through the discipline, character building and attitude that entailed in sports development, compose the foundation of every youth in transforming themselves into a productive and emulative member of our society;

WHEREAS, Sports Program keeps all our youths from bad vices and illegal drugs, alcohol and the likes;

WHEREAS, Sports Program is an avenue to excel their talents on their respective disciplines which could gain them benefits like studying privileges in prestigious university. It can help their families particularly in daily living, represent their respective areas in sports competitions and build a legacy in sports of their own. Thus, ineluctable, the sports development program shall be given attention which entails time, program and funding which leads to the creation of this ordinance;

NOW THEREFORE, on motion of Councilor Marlo PJ A. Alipon, duly seconded by Councilor Miko C. Pelegrina and approved by the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. NAME OF THE COUNCIL – This organization shall be named as the “Los Baños Sports Council”.

SECTION 2. SPORTS DISCIPLINE INCLUDED. Sports include discipline entailed in the organization are the following, to wit:

- a) Basketball
- b) Volleyball
- c) Softball
- d) Chess
- e) Football
- f) Badminton
- g) Table Tennis
- h.) Darts
- i.) Kuntaw
- j.) Boxing
- k.) Running
- l) Cycling
- m) Triathlon
- n) All other sports may be entailed

SECTION 3. AGE AND RESIDENCY OF QUALIFIED MEMBERS. Only Los Baños resident youths from ages 7-20 years old are qualified to be included on the sports development program of the Los Baños Sports Council.

SECTION 4. GENDER QUALIFICATIONS - All genders as long as consistent with Section 2 and 3 shall be qualified to be members of the Los Banos Sports Council.

SECTION 5. PARENTAL / GUARDIAN CONSENT - All youths who are to be accepted as member of the Los Baños Council shall have a secured parental/guardian consent, non acceptance if otherwise.

SECTION 6. ORGANIZATIONAL STRUCTURE, DUTIES AND FUNCTIONS - Stated hereunder is the organizational structure of the Los Baños Sports Council:

- Chairman : Municipal Mayor
- Vice Chairman : Sangguniang Bayan Member (SK Federation President)
- Members : Liga President
Local Youth and Development Office (LYDO)
Rural Helath Unit (RHU)
Municipal Disaster Risk Reduction and Management Council (MDRRMC)
Gender and Development Office (GAD)
Department of Education (DepED)
At least three (3) Non-Government Organization (NGO)

SECTION 7. ROLE OF THE LOCAL YOUTH AND DEVELOPMENT OFFICE – The Local Youth Development Office (LYDO) thru its Sports Development Unit will be the implementing office of the Los Baños Sports Council. Personnel from Local Youth Development Office – Sports Development Section shall be the over all program Director, Trainors and Assistant Trainors.

- SECTION 8. SOURCE OF FUNDS - Los Banos Sports Council shall be funded by the Local Youth and Development Office (LYDO).
- SECTION 9. MEETINGS - The Council shall meet once a month at the discretion of the chairman as to its schedule.
- SECTION 10. EQUIPMENT - Training equipment shall be provided by the LYDO.
- SECTION 11. TRAINING VENUES. Municipal designated training areas for respective sports discipline shall be provided thru the Local Youth Development Office.
- SECTION 12. PROGRAM MANDATE - Over-all Program shall entail Trainings, Leagues and countenance on all potential athletes on their endeavour to be part of the School Varsity Team or in representing our beloved Municipality on all Tournaments outside Los Baños. Countenance can be in the form of transportation, accommodation, cash or other forms that could be of help to our potential athletes; Coordination with Other Municipalities and Universities/Schools/Colleges shall also be maintained to serve the council's purpose.
- SECTION 13. EFFECTIVITY - Los Banos Sports Council shall function as supported by this ordinance fifteen (15) days upon the approval the same.


