ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY TADLAC, LOS BAÑOS, LAGUNA AMOUNTING TO ONE MILLION SIX HUNDRED SIXTY NINE THOUSAND NINE HUNDRED EIGHTY THREE PESOS AND 61/100 (P1,669,983.61) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Tadalac, Los Baños, Laguna in the amount of One Million Six Hundred Sixty Nine Thousand Nine Hundred Eighty Three Pesos and 61/100 (P1,669,983.61) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of One Million Six Hundred Sixty Nine Thousand Nine Hundred Eighty Three Pesos and 61/100 (P1,669,983.61) shall cover the expenses for MOOE: Training and Seminar Expenses – P100,000.00; Oil, Fuel and Lubricants Expenses – P65,000.00, Electricity Expenses – P40,000.00;

Office Supplies Expenses – P17,771.77; Drugs and Medicine Expenses – P50,000.00; Repair and Maintenance-Motor Vehicles – P43,508.11; Other Supplies and Materials – P10,000.00; Telephone Expenses – P25,000.00; 20% BDF: Purchase of CCTV camera – P800,000; Construction of Barangay pathway – P200,000.00; Rehabilitation of Line/Open Canal – P30,907.33; 10% SK: Bayle sa Kalye – P80,000.00; Inter Barangay Sports League – P80,000.00; Semi-Expandable Machinery & Equipment: Speaker/Sound System (one unit) – P10,000.00; Printer (one unit) – P10,000.00; SK Assessment – P48,998.36; GAD: Purchase of Medicines – P24,499.18; Calamity Fund: Purchase of Collapsible Tent – P24,499.18; SC/PWD: Procurement of Office Supplies – P4,899.84; BCPC: Family Day – P4,899.84.


SECTION 3. SOURCE OF FUNDS – The amount of One Million Six Hundred Sixty Nine Thousand Nine Hundred Eighty Three Pesos and 61/100 (P1,669,983.61) of Barangay Tadlac shall be sourced from the Beginning Balance (20% BDF) – P1,000,000.00; Beginning Balance (10% SK) – P180,000.00; Excess Income Incurred for 2019: (Real Property Tax-1st to 2nd quarter - P199,281.94), (Barangay Clearance-Jan. to June, 2019 – P12,385.00), IRA-Jan. to July, 2019 – P154,536.67), Environmental fees (Jan. to June, 2019 – P123,780.00) = Total P389,983.61.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2018 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


