ORDINANCE NO. 2019-1867

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY MAYONDON, LOS BAÑOS, LAGUNA AMOUNTING TO TWO HUNDRED NINE THOUSAND PESOS ONLY (PHP 209,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Mayondon, Los Baños, Laguna amounting to Two Hundred Nine Thousand Pesos Only (Php 209,000.00) for fiscal year 2019.
- SECTION 2. COVERAGE – The amount of Two Hundred Nine Thousand Pesos (Php 209,000.00) shall cover the expenses for MOOE: Electricity Expenses – P 50,000.00; Fuel, Oil, and Lubricants Expenses – P 50,000.00; Office Supplies Expenses 50,000.00; Repair and Maintenance of Transportation Equipment – 59,000.00.

SECTION 3. SOURCE OF FUNDS – The amount of Two Hundred Nine Thousand Pesos (Php 209,000.00) of Barangay Mayondon shall be sourced from the Realignment/Reversion: Capital Outlay (Information and Communication Technology Equipment – P 100,000.00); (Communication Equipment – P 109,000.00) – Total of P 209,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
