ORDINANCE NO. 2019-1868

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY BAGONG SILANG, LOS BAÑOS, LAGUNA AMOUNTING TO THREE HUNDRED TWENTY THOUSAND PESOS ONLY (PHP320,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Bagong Silang, Los Baños, Laguna amounting to Three Hundred Twenty Thousand Pesos Only (Php 320,000.00) for fiscal year 2019.

SECTION 2. COVERAGE – The amount of Three Hundred Twenty Thousand Pesos Only (Php 320,000.00) shall cover the expenses for **MOOE**: Training Expense - P 29,000.00; Office Supplies – P 16,000.00; Fuel, Oil and Lubricant Expense – P 20,000.00; Insurance Expense – P 5,000.00; Representation Expense (Civic Parade, Barangay Night, Barangay Booth)

– P 35,000.00; Other Supplies and Materials Tourism-Bañamos Celebration (Fabrication of Barangay Booth) – P 15,000.00. for **BDF**: Water System (Construction of Ferrocement Water Tank) – P 100,000.00. and for **SK FUND**: Representation Expense Tourism Bañamos Celebration (Bayle sa Kalye, Civic Parade) – P 80,000.00; Donation (Mr. and Ms. LB, Bañamos Celebration) – P 20,000.00.


SECTION 3. SOURCE OF FUNDS – The amount of Three Hundred Twenty Thousand Pesos Only (Php 320,000.00) of Barangay Bagong Silang shall be sourced from the Beginning Balance (Gen Fund) – P 120,000.00; Beginning Balance (20% BDF) – P 100,000.00 and Beginning Balance (10% SK Fund) – P 100,000.00; - total of P 320,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
