**ORDINANCE NO. 2019-1869**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY BAYBAYIN I, LOS BAÑOS, LAGUNA AMOUNTING TO SIX HUNDRED THOUSAND PESOS ONLY (PHP600, 000.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Baybayin, Los Baños, Laguna amounting to Six Hundred Thousand Pesos Only (Php 600,000.00) for fiscal year 2019.

SECTION 2. COVERAGE – The amount of Six Hundred Thousand Pesos Only (Php 600,000.00) shall cover the expenses for Continuing Balance (20% BDF): Construction/Rehabilitation of Multi-Purpose Hall – P 600,000.00.

SECTION 3. SOURCE OF FUNDS – – The amount of Six Hundred Thousand Pesos Only (Php 600,000.00) of Barangay Baybayin shall be sourced from the Continuing Balance (20% BDF) – P 600,000.00.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
