**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY TIMUGAN, LOS BANOS, LAGUNA AMOUNTING TO ONE HUNDRED SIXTY THOUSAND PESOS (PhP 160, 000.00) FOR THE YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Timugan, Los Banos, Laguna amounting to One Hundred Sixty Thousand Pesos (PhP 160, 000.00) for the year 2019.
- SECTION 2. COVERAGE – The amount of One Hundred Sixty Thousand Pesos (PhP 160, 000.00) shall cover the expenses for MOOE: Other Supplies and materials (Bañamos Festival) - P 10,000.00; Insurance Expense – P 8,000.00; Repair and Maintenance – Transportation Equipment P 72,000.00; Accountable Forms – P 10,000.00; and CAPITAL OUTLAYS:

SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Sixty Thousand Pesos (PhP 160, 000.00) of Barangay Timugan shall be sourced from the Beginning Balance– P 160, 000.00.


SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160.

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


