

**AN ORDINANCE CREATING THE POSITION OF AGRICULTURIST II WITH  
SALARY GRADE 15 AT THE MUNICIPAL AGRICULTURIST OFFICE.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA,  
in session assembled, THAT:

SECTION 1. Civil Service Commission (CSC) basic qualification standards are as follows: 

EDUCATION : Bachelor's Degree relevant to the job  
EXPERIENCE : 1 year of relevant experience  
TRAINING : 4 hours of relevant training  
ELIGIBILITY : Career Service (Professional)

SECTION 2. The duties and responsibilities shall be as follows:

- a. Works in various field and office duties;
- b. Gives technical assistance and seminars to farmers on modern technologies on farming;
- c. Coordinates and informs farmers about agricultural programs implemented by the local and national government, technical support, funding programs and policies;
- d. Supervises the dispersal of farm inputs and seedlings;
- e. Consolidates with other line agencies regarding agricultural programs that will be implemented;
- f. Prepares and submits to the Municipal Agriculturist the master list of farmers of the municipality which is updated yearly;
- g. Prepares documentary requirements for Agricultural machineries awarded to local farmers' association by the LGU and other line agencies;
- h. Prepares and maintains agricultural database for office record;
- i. Promotes best management practices for the advancement of agriculture;
- j. Provides liaison and general counselling in the various fields of agriculture such as livestock, crops, poultry and engineering;
- k. Finds solutions to problems and issues posed by clients;
- l. Conducts research and consults with agriculture specialists;
- m. Assists with the promotion and delivery of the Environmental Farm Planning and other initiatives through workshops, educational presentations and one-on-one correspondence with farmers throughout the municipality;


SECTION 3. The source of funds shall be taken from the Annual Budget of CY 2019;

SECTION 4. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


