**AN ORDINANCE CREATING THE POSITION OF COMMUNICATION EQUIPMENT
OPERATOR I WITH SALARY GRADE 4 AT THE OFFICE OF THE
MAYOR/MUNICIPAL ACTION CENTER.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. Civil Service Commission (CSC) basic qualification standards are as follows:

EDUCATION : Completion of two years studies in College or High School
Graduate with relevant vocational/trade course

EXPERIENCE : None Required

TRAINING : None Required

ELIGIBILITY : Appropriate License

SECTION 2. The duties and responsibilities shall be as follows:

- a. Monitor, receive, and transmit signal, message, phone call, radio transmission, or other communication from a person or device indicating the existence of an emergency;
- b. Dispatch police, fire, EMS and other emergency units and personnel as needed;
- c. Receive authorized requests for towing of motor vehicles, determine "on call" wrecker service, and dispatch tow truck(s) to appropriate location;
- d. Prepare and maintain up-to-date telephone listings, including confidential listings, for hospitals, veterinarians, medical personnel, court personnel, public transportation and utilities, local businesses, municipal officials and other persons and entities;
- e. Record and log radio transmissions and telephone calls as needed;
- f. Prepare and maintain up-to-date street locations and residency listings for use by municipal police, fire, and medical emergency personnel;
- g. Ensure timely testing of all equipment and communication services and advise supervisors of needed repairs as necessary;
- h. Maintain a variety of other records related to municipal departments' statistics, and prepare reports related to activities as requested by appropriate municipal authorities;
- i. Receive all public complaints/grievances with regards to peace and order, waste management, erring municipal personnel and other concern;
- j. Refer to and coordinate with concern departments/offices/units of the municipal government and all public complaints/grievances for immediate action;
- k. Assigns motor vehicles and drivers for conveyance of freight or passengers. Compiles list of available vehicles. Issues keys, record sheets, and credentials to drivers;
- l. Record time of departure, destination, cargo, and expected time of return. Investigates overdue vehicles. Directs activities of drivers, using two-way radio. May maintain record of mileage, fuel used, repairs made, and other expenses;
- m. Performs other related duties assigned.

SECTION 3. The source of funds shall be taken from the Annual Budget of CY 2019;

SECTION 4. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


