ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY SAN ANTONIO, LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED SEVENTY THOUSAND PESOS ONLY (PHP 170,000.00) FOR FISCAL YEAR 2019

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 4 of Barangay San Antonio, Los Baños, Laguna amounting to One Hundred Seventy Thousand Pesos Only (Php 170,000.00) for fiscal year 2019;

SECTION 2. COVERAGE – The amount of One Hundred Seventy Thousand Pesos Only (PhP 170,000.00) shall cover the expenses for GENERAL FUND - Maintenance and Other Operating Expenses (MOOE): Electricity Expense – P 80,000.00; Conduct of Barangay Assembly – P 50,000.00; Environment & Sanitary Services – P 40,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Seventy Thousand Pesos Only (PhP 170,000.00) of Barangay San Antonio, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) add: Income Sources (Funds Actually Available Certified by the Local Treasurer or New Revenue Source or Items to be realigned in Times of Public Calamity) – P 170,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
