ORDINANCE NO. 2019-1888

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY ANOS, LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED NINETY THOUSAND PESOS ONLY (PHP 190,000.00) FOR FISCAL YEAR 2019

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Anos, Los Baños, Laguna amounting to One Hundred Ninety Thousand Pesos Only (PhP 190,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of One Hundred Ninety Thousand Pesos Only (PhP 190,000.00) of Barangay Anos, Los Baños, Laguna shall cover the expenses for MOOE: 1) Training and Seminar Expenses – P 36,000.00; 2) Oil, Fuel and Lubricant Expenses – P 40,000.00; 3) Electricity Expenses – P 30,000.00; 4) Telephone/Mobile Expenses – P 12,000.00; 5) Internet

Subscription Expenses – P 8,000.00; 6) Repair and Maintenance – Motor vehicles – P 20,000.00; 7) Fidelity Bond Premiums – P 19,000.00; & Oplan Kaluluwa – P 25,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Ninety Thousand Pesos Only (PhP 190,000.00) of Barangay Anos, Los Baños, Laguna shall be sourced from the Beginning Balance: Income Sources: (Funds Actually Available Certified by Local Treasurer, or New Revenue Sources, or Items to be realigned in Times of Public Calamity) – P 190,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
