**ORDINANCE NO. 2019-1889**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY TUNTUNGIN-PUTHO, LOS BAÑOS, LAGUNA AMOUNTING TO SEVEN HUNDRED THIRTY THOUSAND FIVE HUNDRED SEVENTY ONE PESOS ONLY (PhP 730,571.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Tuntungin-Putho, Los Baños, Laguna amounting to Seven Hundred Thirty Thousand Five Hundred Seventy One Pesos Only (PhP 730,571.00) for fiscal year 2019;

SECTION 2. COVERAGE – The amount of Seven Hundred Thirty Thousand Five Hundred Seventy One Pesos Only (PhP 730,571.00) of Barangay Tuntungin-Putho, Los Baños, Laguna shall cover the expenses for MOOE:

Fuel, Oil Lubricants Expenses – P 100,000.00; Electricity Expenses – P 50,000.00; Repair Motor Vehicle – P 118,571.00; Environmental/Sanitary Services – P 12,000.00; Travelling Expenses – P 50,000.00; CO: Furniture and Fixture (Session tables with chairs) – P 150,000.00; GAD: Health and Nutrition Program Purchase of Medicine – P 50,000.00; SK: Youth Assessment/Capability Building – P 160,000.00; Basketball/Volleyball League – P 40,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of Seven Hundred Thirty Thousand Five Hundred Seventy One Pesos Only (PhP 730,571.00) of Barangay Tuntungin-Putho, Los Baños, Laguna shall be sourced from the Beginning Balance: General Fund – P 530,571.00 & Sangguniang Kabataan Fund – P 200,000.00;


SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
