ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY MALINTA, LOS BAÑOS, LAGUNA AMOUNTING TO NINE HUNDRED FIFTY THOUSAND PESOS ONLY (PhP 950,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Malinta, Los Baños, Laguna amounting to Nine Hundred Fifty Thousand Pesos Only (PhP 950,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of Nine Hundred Fifty Thousand Pesos Only (PhP 950,000.00) of Barangay Malinta, Los Baños, Laguna shall cover the expenses for MOOE: Training Expenses – P 150,000.00; Office Supplies

Expenses – P 10,000.00; Other Supplies and Materials Expenses – P 10,000.00; Fuel, Oil, Lubricants Expenses – P 100,000.00; Electricity Expenses – P 60,000.00; Accountable Forms Expenses – P 3,000.00; Repair & Maintenance – Motor Vehicle Expenses – P 15,000.00; Representation Expense – P 2,000.00; Social Welfare Program: Damayan sa Kapwa – P 50,000.00; Provision of 1 Unit Ambulance – P 550,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Nine Hundred Fifty Thousand Pesos Only (PhP 950,000.00) of Barangay Malinta, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) – P 350,000.00; Continuing Balance (BDRRM) – P 550,000.00; Unexpected Balance (BDRRM 2014) P 50,000.00; Add Income Sources: (Funds Actually Available Certified by Local Treasurer or New Revenue Sources or item/s to be realigned in times of Public Calamity;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
