ORDINANCE NO. 2019-1899

AN ORDINANCE AMENDING SECTION 29 OF MUNICIPAL ORDINANCE NO. 2011-1082 ENTITLED "NEW ORDINANCE FOR TRICYCLES IN THE MUNICIPALITY OF LOS BAÑOS", PROVIDING NEW GUIDELINES FOR TRANSFER OF OWNERSHIP OF FRANCHISE.

WHEREAS, Section 447 (3-IV) of Republic Act 7160 also known as the Local Government Code of 1991 stated that "The Sangguniang Bayan, subject to the guidelines prescribed by the Department of Transportation and Communications, regulates the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;

WHEREAS, Article IX, Section 29 of the Municipal Ordinance No. 2011-1082 "New ordinance for the tricycles in the Municipality of Los Baños" provides that "In case of death, disability and permanent incapacity of the current owner/operator to drive the tricycle unit, the transfer of ownership of franchise shall be to his/her immediate family";

WHEREAS, on our current phase, amendments on the existing provision is of huge significance, which leads to the crafting of this ordinance;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. ARTICLE IX. Provisions on Dropping, Change Motor, Change owner

SECTION 29. In case of death, disability and permanent incapacity of the current owner/operator to drive the tricycle unit, the transfer of ownership of franchise shall be to his/her immediate family;

Section 29 shall now read as:

SECTION 29. In case of death, disability, and permanent incapacity of the current owner/operator to drive the tricycle unit, the transfer of ownership can be legally transferred to anyone provided that the recipient of the transfer will comply with all other requirements to secure a franchise as provided by the ruling municipal ordinances;

29.1 Change motor will not *ipso facto* result in the cancellation of franchise; existing secured franchise can be used as franchise for the new motor provided that approved application form for change motor shall be secured by the applicant and the replaced motor shall not be used again for tricycle.

SECTION 2. SEPARABILITY CLAUSE – If any part of this ordinance is declared unconstitutional or unlawful, such declaration shall not affect the other parts or sections thereof;

SECTION 3. REPEALING CLAUSE – All other Sections/Provisions of previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly;

SECTION 4. EFFECTIVITY- This ordinance shall take force and effect upon approval.
