**ORDINANCE NO. 2019-1905**

**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY BAYBAYIN, LOS BAÑOS, LAGUNA AMOUNTING TO TWO HUNDRED EIGHTEEN THOUSAND PESOS (PHP 218,000.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 4 of Barangay Baybayin, Los Baños, Laguna amounting to Two Hundred Eighteen Thousand Pesos (PhP 218,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of Two Hundred Eighteen Thousand Pesos (PhP 218,000.00) of Barangay Baybayin, Los Baños, Laguna shall cover the expenses for MOOE: Training Expenses – P 160,000.00, Fuel, Oil, Lubricants Expenses – P 20,000.00, Electricity Expenses – P 20,000.00; Social Welfare Program: Damayan sa Kapwa – P 18,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of Two Hundred Eighteen Thousand Pesos (PhP 218,000.00) of Barangay Baybayin, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) – P 200,000.00, Unexpended Balance (BDRRM 2014) – P 18,000.00; add: Income Sources: (Funds Actually Available Certified by Local Treasurer or New Revenue Sources or item/s to be Realigned in times of Public Calamity);


SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


