ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY MAAHAS, LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED THIRTY THOUSAND PESOS (PHP 130,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Maahas, Los Baños, Laguna amounting to One Hundred Thirty Thousand Pesos (PhP 130,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of One Hundred Thirty Thousand Pesos (PhP 130,000.00) of Barangay Maahas, Los Baños, Laguna shall cover the expenses for MOOE: Electricity Expenses – P 50,000.00, Other Supplies and Materials (Semi-Expandable, Furniture and Fixture Procurement of 10 Session Tables, Chairs and Table Name Plate) – P 80,000.00;

- SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Thirty Thousand Pesos (PhP 130,000.00) of Barangay Maahas, Los Baños, Laguna shall be sourced from the Realignment/Reversion c/o (General Fund) – PhP 130,000.00;
- SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;
- SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
