ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 5 OF BARANGAY MAYONDON, LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED THOUSAND PESOS (PHP 100,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 5 of Barangay Mayondon, Los Baños, Laguna amounting to One Hundred Thousand Pesos (PhP 100,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of One Hundred Thousand Pesos (PhP 100,000.00) of Barangay Mayondon, Los Baños, Laguna shall cover the expenses for MOOE: Paskuhan sa Barangay 2019 (Christmas Tree Making and Christmas Gimik) – P 100,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Thousand Pesos (Php 100,000.00) of Barangay Mayondon, Los Baños, Laguna shall be sourced from the SK Funds: Capital Outlay – P 100,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
