ORDINANCE NO. 2019-1908

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA AMOUNTING TO FOUR HUNDRED SEVENTY THOUSAND PESOS (PHP 470,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 4 of Barangay Lalakay, Los Baños, Laguna amounting to Four Hundred Seventy Thousand Pesos (PhP 470,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of Four Hundred Seventy Thousand Pesos (PhP 470,000.00) of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for MOOE: Training Expenses P – 150,000.00, Electricity Expense – P 20,000.00, Fuel Expense – P 25,000.00, Repair and Maintenance (Transportation Equipment) – P 5,000.00; Social Welfare Program: Damayan sa Kapwa – P 70,000.00; SK Fund: SK Year End Assesment – P 200,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Seventy Thousand Pesos (PhP 470,000.00) of Barangay Lalakay, Los Baños, Laguna shall be sourced from Beginning Balance (General) – P 200,000.00; Beginning Balance – P 200,000.00; Unexpended Balance (BDRRMF 2014) – P 70,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
