ORDINANCE NO. 2019-1915

AN ORDINANCE ADOPTING THE NATIONAL NUTRITION COUNCIL (NNC) GOVERNING BOARD RESOLUTION NO. SERIES OF 2017 AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) MEMORANDUM CIRCULAR 2018-42 WHICH DIRECT ALL CONCERNED STAKEHOLDERS FOR THE ADOPTION AND IMPLEMENTATION OF THE PHILIPPINE PLAN OF ACTION FOR NUTRITION 2017-2022.

WHEREAS, this Ordinance directs all concerned offices and agencies to adopt and implement the Philippine Plan of Action for Nutrition (PPAN) 2017-2022 through the NNC Governing Board Resolution No.1 Series of 2017 and the DILG MC 2018-42;

WHEREAS, PPAN 2017-2022 is the country's blueprint to address malnutrition among Filipinos. It is an integral part of the Philippine Development Plan 2017-2022. It is one of the country's commitments to the global community as embodied in the 2030 Sustainable Development Goals particularly the goal on ending hunger, achieving food security and improving nutrition, the 2025 Global Targets for Maternal, Infant, and Young Child Nutrition;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, IN SESSION ASSEMBLED THAT:


SECTION 1. **ROLE OF LGUs** — The LGU, through the Municipal Nutrition Action Office and other related offices and agencies, shall have the following tasks:

(a) Ensure the formulation, or if existing, revision/updating of the Local Nutrition Action Plan to include programs, projects, and activities that converge in families of the nutritionally vulnerable individuals (pregnant women, lactating women, children 0-23 month's old, malnourished children under 5 years of age) as well as communities/barangays with high levels of undernutrition or over nutrition.

(b) Implement, monitor, and evaluate their respective Local Nutrition Action Plans which includes but not limited to the following PPAN programs:

- b. Infant and Young Child Feeding;
- b. Integrated Management of Acute Malnutrition;
- b. Dietary Supplementation;
- b. National Nutrition Promotion for Behavior Change;
- b. Micronutrient Supplementation;
- b. Mandatory Food Fortification; Nutrition in Emergencies;
- b. Overweight and Obesity Management;
- b. Nutrition sensitive programs that will improve physical and economic access to food, access to sanitary toilets and safe drinking water, responsible parenthood, among others;
- b. Annual conduct of Operation Timbang Plus; and
- b. Monitoring of the child growth and development especially during the first 1000 days of life.

(c) Include in their respective Local Development Plans and Annual Investment Programs (AIP), applicable PPAN programs to ensure adequate funding for nutritional impact.



(d) Strengthen and ensure the functionality of the Municipal Nutrition Council. 

(e) Sustain the existing nutrition workers, including the Municipal Nutrition Action Officer (MNAO), MNAO staff, and Barangay Nutrition Scholars and other volunteer workers and continually support them through capability building, logistics provision such as weighing scale and height boards, and monetary and non-monetary incentives.

(f) Provide incentives to members of the local nutrition committee to the extent possible.

(g) Develop and implement programs that will ensure good nutrition among its employees in partnership with professional organizations of nutritionist-dietitians.

SECTION 2. **IMPLEMENTING RULES AND REGULATIONS** – The MNAO, in consultation with other concerned agencies, non-government organizations, private sectors and consumer groups involved in nutrition, shall formulate the implementing rules and regulations (IRR) necessary to implement the provisions of this Ordinance within ninety (90) days from the approval of this Ordinance. The IRR issued pursuant to this Section shall take effect thirty (30) days after publication in a local newspaper.

SECTION 3. **REPEALING CLAUSE** – All laws, decrees, rules and regulations, executive orders inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 4. **SEPARABILITY CLAUSE** – If any provision of this Ordinance is declared unconstitutional or unlawful, the remaining provisions shall remain legal and in full effect.

SECTION 5. **EFFECTIVITY** – This Ordinance shall take effect upon its approval.
