AN ORDINANCE ADOPTING THE IMPLEMENTATION AND MONITORING OF THE MUNICIPAL NUTRITION ACTION PLAN.

WHEREAS, National Nutrition Council Governing Board Resolution No.3, Series of 2014 identifies malnutrition, undernutrition, and over nutrition as nutritional problems that should be addressed;

WHEREAS, based on national nutrition surveys, the nutrition situation of the Philippines can be described to be experiencing the double burden of malnutrition;

WHEREAS, undernutrition has far-reaching consequences on child growth and development and the capacity to learn and maximize investments in education as well as the capacity to become economically active and socially active adults;

WHEREAS, over nutrition has been established as one of the risk factors for developing non-communicable diseases;

WHEREAS, there is a need for strategic and purposive action these nutritional problems, and with devolution, local government units play a pivotal role in reversing the trend and ensuring good nutrition among the population;

WHEREAS, the Municipal Nutrition Action Plan shall be the three-year guide of the Local Government Unit (LGU) in addressing these nutritional problems;


WHEREAS, the LGU through the Municipal Nutrition Action Office shall ensure that programs, projects, and activities in the Municipal Nutrition Action Plan are implemented and monitored;


RESOLVED AS IT IS HEREBY RESOLVED, an ordinance adopting the implementation and monitoring of the municipal nutrition action plan.
