**ORDINANCE NO. 2019-1928**

**AN ORDINANCE AMENDING SECTION 7, SUB-SECTION I OF MUNICIPAL ORDINANCE NO. 2011-1076, PROVIDING NEW PENALTIES ON ALL COLORUM VEHICLES.**

**WHEREAS**, Municipal Ordinance No. 2011-1076, A new ordinance on regulations of vehicular traffic in the Municipality of Los Baños and provides penalties for all colorum vehicles was enacted on August 13, 2012;

**WHEREAS**, Section 7 Sub-Section I of Municipal Ordinance No. 2011-1076 particularly defines penalties for out of line/colorum vehicles as well as for those with expired franchise or CPC;

**WHEREAS**, with existing penalties provided, it is inevitable that upon payment of penalties, all colorum vehicles and vehicles with expired franchises continues to ply along roads and performs activities same as with all vehicles registered franchises;

**WHEREAS**, predicament in regulating and abatement of all colorum vehicles and vehicles with expired franchises are present within the Municipality of Los Baños, which leads to the crafting of this ordinance;

**NOW THEREFORE**, on motion of Councilor Marlo PJ A. Alipon, duly seconded by Councilor Geronimo A. Ciceron and approved by all the Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, IN SESSION ASSEMBLED THAT:

SECTION 1. SECTION 7. FINES AND PENALTIES- Violations under this Ordinance shall have a corresponding penalty, as follows:

**I. Prohibited or Illegal Operations of MV**

- a. Out of line/COLORUM with penalty amounting to Two Thousand Five Hundred Pesos (P 2,500.00).
- b. Operating a MV with expired franchise or CPC with penalty amounting to One Thousand Pesos (P 1,000).
- c. Operating or using a For-Hire MV from different of its types of service mentioned in the franchise or CPC with penalty amounting to Two Thousand Five Hundred Pesos (P 2,500.00).

*Shall now read as:*

**I. Prohibited or Illegal Operations of MV**

- a. Penalties for Colorum Vehicle, Motor vehicle with expired franchise and for those operating which are inconsistent with the types of service provided in the franchise, shall be impounding of Vehicle.
- b. Impounded Motor Vehicle can be taken off from impounded status and re-possessed upon payment of P 2,500 and subsequently complying with the registration requirements in accordance with the violation made.

SECTION 2. **REPEALING PROVISION** – all other provisions provided under other Municipal Ordinances which are inconsistent with any of the provisions of this ordinance shall be repealed and amended accordingly.

SECTION 3. **SEPERABILITY PROVISION** – if any of the provisions entailed in this ordinance is found to be in consisted with the constitution or other national law, all other provisions which are otherwise shall still effect legislation.

SECTION 4. **EFFECTIVITY** – this ordinance shall take effect 15 days upon approval.
