ORDINANCE NO. 2019-1929

AN ORDINANCE AMENDING SECTION 14 OF MUNICIPAL ORDINANCE NO. 2012-1162, REQUIRING CONFISCATION OF FRANCHISE OF "PADYAK" IN EVERY TRAFFIC VIOLATION AS PROVIDED IN THE RESPECTIVE MUNICIPAL ORDINANCES.

WHEREAS, Kautusang Blg. 2012-1611 Kautusang Pambayan sa pangangasiwa ng pagbibigay ng prangkisa sa operasyon ng pampasadang pedicab/padyak, pagpapatupad ng panuntunan at multa para sa paglabag dito sa bayan ng Los Banos, Laguna, provides penalties for each of the respective violations entailed in the same municipal ordinance;

WHEREAS in the existing ordinance, defined is only the penalties to be paid in each respective violations made as provided in the same ordinance;

WHEREAS, consequently no provisions were entailed in cases of failure to pay the mandated fees in each of the respective violations provided in the ordinance, it considering that padyak drivers are not required to secure drivers license which could be an object to be

confiscated in each of every violations made which will compel the respective violators to pay the violation fees, which leads to the crafting of this ordinance;

NOW THEREFORE, on motion of Councilor Marlo PJ A. Alipon, duly seconded by Councilor Mark Lester B. Dizon approved by the Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, IN SESSION ASSEMBLED THAT:

SECTION 1. Kautusang Blg.2012-1162, Sec14 shall now be defined as follows:

VIOLATIONS	PENALTY
NO FRANCHISE	P 200
NO TRU-ID	P 150
NO TERMINAL PERMIT	P 150
ILLEGAL LOADING AND UNLOADING	P 100
GAMBLING, DRINKING OF ALCOHOLIC DRINKS IN LEGAL TERMINAL	P 200
SMOKING WHILE ON ROUTE	P 100
DRIVING IN MINOR AGE	P 150
NO TRASHCAN PROVISION IN PADYAK	P 100
ILLEGAL PARKING	P 100
NO REQUIRED LIGHTS	P 100
NO DESIGNATED PADYAK COLOR	P 100
INAPPROPRIATE DRIVING ATTIRE	P 100
OVER LIMIT AS TO NUMBER OF PADYAK ALLOWED	P 200

Franchise shall be confiscated in every violation and shall be returned upon payment of penalty.

SECTION 2. **REPEALING PROVISION** – all other provisions provided under other Municipal Ordinances which are inconsistent with any of the provisions of this ordinance shall be repealed and amended accordingly.


SECTION 3. **SEPERABILITY PROVISION** – if any of the provisions entailed in this ordinance is found to be inconsistent with the constitution or other national law, all other provisions which are otherwise shall still effect legislation.

SECTION 4. **EFFECTIVITY** – this ordinance shall take effect 15 days upon approval.


