**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 4 OF BARANGAY TUNTUNGIN-PUTHO, LOS BAÑOS, LAGUNA AMOUNTING TO TWO HUNDRED FIFTEEN THOUSAND PESOS ONLY (P 215,000.00) FOR FISCAL YEAR 2019.**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 4 of Barangay Tuntungin- Putho, Los Baños, Laguna amounting to Two Hundred Fifteen Thousand Pesos Only (P 215,000.00) for fiscal year 2019;

SECTION 2. COVERAGE – The amount of Two Hundred Fifteen Thousand Pesos Only (P 215,000.00) of Barangay Tuntungin- Putho, Los Baños, Laguna shall cover the expenses for MOOE: Electricity Expenses – P 50,000.00; Other Supplies & Materials (Semi-Expandable, Furniture & Fixture

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


