ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 2 OF BARANGAY BATONG MALAKE, LOS BAÑOS, LAGUNA AMOUNTING TO ONE MILLION FIVE HUNDRED THOUSAND PESOS ONLY (P 1,500,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 2 of Barangay Batong Malake, Los Baños, Laguna amounting to One Million Five Hundred Thousand Pesos Only (P 1,500,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of One Million Five Hundred Thousand Pesos Only (P 1,500,000.00) of Barangay Batong Malake, Los Baños, Laguna shall cover the expenses for MOOE: Electricity Expenses – P 150,000.00; Office Supplies – P 95, 000.00; Repair and Maintenance – Buildings and other Structures – P 175,000.00; Repair and Maintenance – Transportation Equipment – P 250,000.00; Capital Outlay: Information and

SECTION 3. SOURCE OF FUNDS – The amount of One Million Five Hundred Thousand Pesos Only (P 1,500,000.00) of Barangay Batong Malake, Los Baños, Laguna shall be sourced from the Beginning Balance – P 770,000.00; 20% BDF – Beginning – P 193,000.00; 20% BDF – Continuing – P 537,000.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
