ORDINANCE NO. 2019-1933

ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 3 OF BARANGAY TIMUGAN, LOS BAÑOS, LAGUNA AMOUNTING TO FOUR HUNDRED FIFTY FIVE THOUSAND PESOS ONLY (P 455,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 3 of Barangay Timugan, Los Baños, Laguna amounting to Four Hundred Fifty Five Thousand Pesos Only (P 455,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of Four Hundred Fifty Five Thousand Pesos Only (P 455,000.00) of Barangay Timugan, Los Baños, Laguna shall cover the expenses for MOOE: Training Expenses – P 12,000.00; Fuel, Oil, Lubricants Expenses – P 40,000.00; Electricity Expenses – P 30,000.00;

Repair & Maintenance – Motor Vehicle Expenses – P 18,000.00; Social Welfare Program: 30% Unexpended Balance BDRRM 2014 (Damayan sa Kapwa) – P 65,000.00; BDRRM: 70% Prior Balance 2015, Other Supplies and Materials Stock Piling (Semi Expandable) – P 180,000.00; Provision of Step Ladder, Hard Hat, Axe, and Bolo – P 80,000.00; Medicines (Purchase of Medicine) – P 30,000.00;


SECTION 3. SOURCE OF FUNDS – The amount of Four Hundred Fifty Five Thousand Pesos Only (P 455,000.00) of Barangay Timugan, Los Baños, Laguna shall be sourced from the Beginning Balance – P 100,000.00; Unexpended Balance (BDRRM 2014) – P 65,000.00; 70% Prior Balance 2015 – P 290,000.00; Add: Income Sources (Funds Actually Available Certified by the Local Treasurer or New Revenue Source or Items to be realigned in times of Public Calamity);

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
