ORDINANCE NO. 2019-1934

AN ORDINANCE ESTABLISHING THE "LOS BAÑOS PERFORMING ARTS GROUP" AND ALLOCATING FUNDS THEREOF.

WHEREAS, the Republic Act No. 11392 Section 2 Declaration of Policy. Pursuant to Article II, Sections 17 and 23, and Article XIV, Sections 14, 15 and 18(2) of the Constitution, it is hereby declared the policy of the State to appropriately recognize, designate and support nongovernment organizations that have demonstrated pioneering, consistent and unassailable competence, effectiveness and success in the development, training, documentation and performance of ballet and contemporary dance, orchestral music, choral music, and theater;

WHEREAS, according to United Nations Educational, Scientific and Cultural Organization (UNESCO), "The performing arts range from vocal and instrumental music, dance and theatre to pantomime, sung verse and beyond. They include numerous cultural expressions that reflect human creativity and that are also found;"

NOW, THEREFORE, on motion of Hon. Mike Dexter A. Concio and duly seconded by Marlo PJ A. Alipon and approved by all the Councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA in session assembled, THAT:



SECTION 1. **TITLE** – This ordinance is entitled **An Ordinance establishing the “Los Baños Performing Arts Group” and allocating funds thereof.**

SECTION 2. **RATIONALE** - The establishment of the “Los Baños Performing Arts Group” will help to:

- a. Identify the different forms of the performing arts and their appropriate functions; develop and enhance interpersonal characteristics by exposing their talents and skills to public performances;
- b. Explore and adopt the best possible structure of relationship between the public and private sector at the local level, taking into account varying socio-cultural situations;
- c. Extend recognition of artistic achievement through awards, grants and services to artists and cultural groups which contribute significantly to the exceptional talent of youth in Los Baños;
- d. Encourage and ensure the exercise of freedom of expression without prejudice to the rights of other people and promote the interests and welfare of artists, protecting their rights to intellectual and artistic properties;
- e. Redirect and divert the youth in engaging to various dreadful activities that can corrupt unscrupulously their young minds such as juvenile crimes, drug abuse, premarital sex and teenage pregnancy;
- f. Enrich and promote performing arts in the Municipality;

SECTION 3. **DEFINITION OF TERMS**

- a. Performing Arts - forms of creative activities that are performed in front of an audience, such as drama, music, dance and other forms of public entertainment.
- b. Socio-cultural – combination of social and cultural functions. Related to the different group of people in society and their habits, traditions, and beliefs.
- c. UNESCO – short for United Nations Educational, Scientific and Cultural Organization (French: L'Organisation des Nations unies pour l'éducation, la science et la culture. An agency of the United Nations (UN) with the purpose in promoting international collaboration in educating sciences and culture in order to increase universal respect for justice, the rule of law of human rights along with the fundamental freedom proclaimed in the United Nations Charters;

- d. Intellectual property rights - A right that of a person or a company to have exclusive rights to use its own plans, ideas, or other intangible assets without the worry of competition, at least for a specific period of time. These rights can include copyrights, patents, trademarks, and trade secrets.
- e. Artistic property rights - It applies to works of the mind. Literary and artistic property refers to both the direct rights of the author or creator, as well as to accompanying ancillary rights.
- f. Classical - (typically of a form of art) regarded as representing an exemplary standard; traditional and long-established in form or style.
- g. Mainstream - the ideas, attitudes, or activities that are regarded as normal or conventional; the dominant trend in opinion, fashion, or the arts.
- h. Vocals - a part of a piece of music that is sung. A musical performance involving singing.
- i. Band – a group of musicians who play music together, esp. popular music.
- j. Creative Arts - refers to participation in a range of activities that allow for creative and imaginative expression, such as music, art, creative movement, and drama. The creative arts engage children's minds, bodies, and senses.
- k. Dance - move rhythmically to music, typically following a set sequence of steps.

SECTION 4. **RESPONSIBLE OFFICE** - The Local Youth Development Office (LYDO) of the municipality shall be the responsible office to administer, conduct, conceptualize, craft and implement plans, policies and programs for the “Los Baños Performing Arts Group”.

SECTION 5. **ROLES AND FUNCTIONS** - The LOS BAÑOS PERFORMING ARTS GROUP under the supervision of the Local Youth Development Office shall administer the following:

- a. Undertake a continuing program of training and education for the professional development of performing artists, teachers, directors, designers, performing arts managers, and other artists particular to its performing arts field;
- b. Conduct research relative to particular performing arts and undertake documentation of its activities and programs for the preservation and of dissemination of Filipino masterpieces in the performing arts;
- c. Maintain and promote a standard of artistic excellence in its field that will help elevate the performing arts in the municipality;

- d. Conduct workshops, and seminars for the development and promotion of the performing arts in the municipality;
- e. Conduct continuing audience development program and help promote greater awareness and appreciation.

SECTION 6. **COMPOSITION** - The LOS BAÑOS PERFORMING ARTS GROUP shall be composed of performing artists, teachers, directors, performing arts managers particular to its performing field. The Group shall be consisted of four (4) main categories and shall be divided into subcategories or genres, as follows:

6.1. Vocals

- a. Choir
- b. Solo/Duo/Group
- c. *etc.*

6.2 Band

- a. Show Band
 - Acoustic, Variety and Pop
- b. Orchestra
 - Rondalla, Ethnic and Brass band
- c. *Etc.*

6.3 Creative Arts

- a. Songwriting
- b. Visual Arts
- c. Fashion Design
- d. Dubbing (vocal)
- e. Arts and Crafts
- f. Ramp Models
- g. Comedian
- h. Hosting
- i. Painting
- j. *etc.*

6.4 Dance

- a. Contemporary
- b. Tech-No
- c. Pop-Lock
- d. Hip – Hop
- e. Zamba
- f. Jazz
- g. *Etc.*

SECTION 7. **COVERAGE** - Only legitimate residents of the Municipality of Los Baños that are youth in majority but not exclusively are allowed to join the “Los Baños Performing Arts Group”.

SECTION 8. **BUDGETARY REQUIREMENTS** - The Local Youth Development Office shall incorporate in its annual budget such amount as may be necessary for the operation and effective functioning of the “Los Baños Performing Arts Group”.

SECTION 9. **REPEALING CLAUSE** – All or Sections/Provisions of previous ordinances contrary to or inconsistent with this ordinance shall be deemed repealed or modified accordingly.

SECTION 10. **SEPARABILITY CLAUSE** – If any part of this ordinance is declared unconstitutional or unlawful, such declaration shall not affect the other parts or sections thereof.


SECTION 11. EFFECTIVITY - This Ordinance shall take force and effect upon approval.
