**ORDINANCE NO. 2019-1937**

**AN ORDINANCE AMENDING THE TITLE AND CERTAIN SECTIONS OF ORDINANCE NO. 2001-19 ENTITLED "ORDINANCE CREATING A "MEDICARE PARA SA MASA" MUNICIPAL PROGRAM PURSUANT TO R.A. 7875 FOR THE INDIGENT FAMILIES OF LOS BAÑOS, LAGUNA AND PROVIDING FUNDS THEREFOR "**

BE IT ORDAINED BY THE SANGGUNIANG BAYAN, in session assembled, THAT:

SECTION 1. This ordinance amends the title of Ordinance No. 2001-19:

"ORDINANCE CREATING A "MEDICARE PARA SA MASA" MUNICIPAL PROGRAM PURSUANT TO R.A. 7875 FOR THE INDIGENT FAMILIES OF LOS BAÑOS, LAGUNA AND PROVIDING FUNDS THEREFOR" shall now read as:

**“ORDINANCE CREATING PHILHEALTH-SPONSORED MUNICIPAL PROGRAM PURSUANT TO R.A. 7875 FOR THE INDIGENT FAMILIES OF LOS BAÑOS, LAGUNA AND PROVIDING FUNDS THEREFOR”**

SECTION 2. This Ordinance also amends certain sections of Ordinance No. 2001-19, to wit:

a. SECTION 3 and SECTION 5 both state the municipal program, as “Medicare para sa Masa”, shall now read as follows:

**SECTION 3. A PhilHealth-sponsored municipal program pursuant to R.A. 7875 is hereby created in order to support financially the municipal wide health program to these targeted sectors.**

**SECTION 5. The Municipal Health Officer is hereby ordered to carry out the full implementation of the PhilHealth-sponsored municipal program and regularly report to the Sangguniang Bayan the progress, development and the other incidentals which in the view of the Sangguniang Bayan needs further legislative and appropriate actions.**

b. SECTION 7. Which states that the budgetary allocation be embodied in the Annual Budget of the Year 2002, shall now read as.

**SECTION 7. This Ordinance shall take effect upon approval subject to the itemized budgetary allocation to be embodied in the Continuing Fund.**

SECTION 3. **SEPARABILITY CLAUSE** - This Ordinance partly amends, repeals and modify Ordinance No. 200-19. Any inconsistency with previous/other ordinances, this Ordinance shall prevail. Any part which has been declared unconstitutional, the other parts shall remain in force.

SECTION 4. **REPEALING CLAUSE** - All ordinances, rules and regulations inconsistent with this Ordinance are hereby repealed and modified.

SECTION 5. **EFFECTIVITY** - This Ordinance shall take force and effect upon approval.


