ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 5 OF BARANGAY BAGONG SILANG, LOS BAÑOS, LAGUNA AMOUNTING TO ONE HUNDRED FIFTEEN THOUSAND TWO HUNDRED SIXTY ONE PESOS ONLY (P 115,261.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 5 of Barangay Bagong Silang, Los Baños, Laguna amounting to One Hundred Fifteen Thousand Two Hundred Sixty One Pesos Only (P 115,261.00) for fiscal year 2019;

SECTION 2. COVERAGE – The amount of One Hundred Fifteen Thousand Two Hundred Sixty One Pesos Only (P 115,261.00) of Barangay Bagong Silang, Los Baños, Laguna shall cover the expenses for Personal Services: Other Bonuses and Allowance – Service Recognition Incentives –

SECTION 3. SOURCE OF FUNDS – The amount of One Hundred Fifteen Thousand Two Hundred Sixty One Pesos Only (P 115,261.00) of Barangay Bagong Silang, Los Baños, Laguna shall be sourced from the Beginning Balance (General Fund) – P 79,000.00; Add: Income Sources : PS Savings: Monetization – P 25,252.00; Mid-Year Bonus – P 2, 709.00; Terminal Leave Pay – P 2,000.00; Sports Coordinator – P 6,300.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;

SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
