ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 5 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA AMOUNTING TO EIGHTY EIGHT THOUSAND PESOS ONLY (P 88,000.00) FOR FISCAL YEAR 2019.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 5 of Barangay Lalakay, Los Baños, Laguna amounting to Eighty Eight Thousand Pesos Only (P 88,000.00) for fiscal year 2019;
- SECTION 2. COVERAGE – The amount of Eighty Eight Thousand Pesos Only (P 88,000.00) of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for Personal Services: Other Bonuses and Allowances Service Recognition Incentive – P 88,000.00;

SECTION 3. SOURCE OF FUNDS – The amount of Eighty Eight Thousand Pesos Only (P 88,000.00) of Barangay Lalakay, Los Baños, Laguna shall be sourced from the Beginning Balance (General): Realignment PS Savings - P 16,582.00; Medical Assistance – P 44,000.00; Monetization – P 8,910.00; BPSO Allowance – P 5,080.00; Barangay Justices Allowance – P 13,428.00;

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
