**ORDINANCE NO. 2020-1942**

**AN ORDINANCE REGULATING THE OPERATIONS OF THE LOS BAÑOS THERAPEUTIC MASSAGE CENTER AND HEALTH SPA.**

WHEREAS, the Code on Sanitation Presidential Decree No. 856 states that the health of the people, being of paramount importance, all efforts of public services should be directed towards the protection and promotion of health;

WHEREAS, the Local Government Unit of the municipality of Los Baños take on the elevation, promotion, protection and preservation of the health of its people and increase the health standards and values of individuals and communities throughout the municipality;

WHEREAS, the Local Government Code of 1991 has opened opportunities for local government units (LGUs) to generate more revenues beyond traditional sources like the Internal Revenue Allotment (IRA);

NOW THEREFORE, on motion of Hon. Mike Dexter A. Concio, duly seconded by Councilor Marlo PJ A. Alipon and approved by all the councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA  
in session assembled, THAT:

SECTION 1. **TITLE** - This ordinance is entitled "An Ordinance Regulating the Operation of the Los Baños Therapeutic Massage Center and Health Spa."

SECTION 2. **COVERAGE** - Non-Los Baños resident patrons and customers of The Los Baños Therapeutic Massage Center and Health Spa are required to pay the adequate amount of Ten Pesos (P 10.00) per head upon entrance. They are still encouraged to give their voluntary donation. Only legitimate residents of the Municipality of Los Baños are waived to the Ten Pesos (P 10.00) entrance fee, nevertheless, still permissible for their voluntary monetary contribution to the facility.

SECTION 3. **RESPONSIBLE OFFICE** - The Municipal Tourism Office shall be the designated office of the Local Government Unit of Los Baños to facilitate and secure all necessary matters that will be needed in the operation of the Los Baños Therapeutic Massage Center and Health Spa.

SECTION 4. **GUIDELINES** - Legitimate residents of Los Baños shall be required to show proof of their residency upon entrance to the Los Baños Therapeutic Massage Center and Health Spa. Failing to do so shall entitle them to the Ten Pesos (P 10.00) entrance fee just like for those non-Los Baños residents;


SECTION 5. **REPEALING CLAUSE** - All or Sections/Provisions of previous ordinances contrary to or inconsistent with this ordinance shall be deemed repealed or modified accordingly;

SECTION 6. **SEPARABILITY CLAUSE** - If any part of this ordinance is declared unconstitutional or unlawful, such declaration shall not affect the other parts or sections thereof;

SECTION 11. **EFFECTIVITY** - This Ordinance shall take force and effect upon approval.
