
ORDINANCE NO. 2020-1944

ORDINANCE APPROVING AND ADOPTING THE MTPFRB RESOLUTION NO. 2020-03, DATED JANUARY 17, 2020, ENTITLED “ RESOLUTION RECOMMENDING TO THE SANGGUNIANG BAYAN TO AUTHORIZE THE TRANSFER OF OWNERSHIP OF TRICYCLE FRANCHISE TO ANY QUALIFIED TRANSFEREE.”

WHEREAS, the Sangguniang Bayan of Los Baños enacted Municipal Ordinance 2011-1082 dated October 17, 2011 entitled “New Municipal Ordinance on the Franchise and Operation of Motorized Tricycles in Los Baños, Laguna to be known as the “New Ordinance for Tricycles in the Municipality of Los Baños”/ *Bagong Kautusang Pambayan na Nagsasaad ng Pagpapaprangkisa at Pamamahala ng Operasyon sa Lahat ng Traysikel na may Motor sa Bayan ng Los Baños, Laguna na Tatawaging “Bagong Ordinansa para sa mga Traysikel sa Bayan ng Los Baños;*

WHEREAS, Executive Order No. 149 Series of 2019 dated September 2, 2019 entitled “An Order Reconstituting the Municipal Tricycle and Pedicab Franchising and Regulatory Board (MTPFRB)” was signed by the Local Chief Executive;



WHEREAS, Ordinance No. 2011-1082 and Executive Order No. 149 Series of 2019 both state the powers and functions of the MTPFRB as a policy making body;
Page 2. MTPFRB Resolution No. 2020-03 dated January 17, 2020

WHEREAS, Article IX, Section 29 of the abovementioned Ordinance states that “In case of death, disability and permanent incapacity of the current owner/operator to drive the tricycle unit, the transfer of ownership shall be to his/her immediate family”;

WHEREAS, Ordinance No. 2019-1899 amended the said section and provided new guidelines for transfer of ownership of franchise which states that, “In case of death, disability and permanent incapacity of the current owner/operator to drive the tricycle unit, the transfer of ownership can be legally transferred to anyone provided that the recipient will comply with all other requirements to secure a franchise as provided by the ruling municipal ordinances”;


WHEREAS, during the recently held MTPFRB meeting on January 17, 2020, the Board agreed upon on another proposed amendment on the guidelines for transfer of ownership of franchise which is to authorize the transfer of ownership of franchise not only in such case of death, disability and permanent incapacity to any qualified transferee;

NOW THEREFORE, on motion of Councilor Marlo PJ A. Alipon, duly seconded by Councilwoman Josephine S. Evangelista and Councilor Mike Dexter A. Concio, and concurred by all other members present;


