ORDINANCE NO. 2020-1947

**AN ORDINANCE GIVING LEGAL PERSONALITY TO LOS BAÑOS TRAFFIC
MANAGEMENT OFFICE (LBTMO) TO IMPOUND MOTOR VEHICLES IN EVERY
VIOLATION OF ALL TRAFFIC RULES AND REGULATIONS PROVIDED IN THE
RESPECTIVE MUNICIPAL ORDINANCES, IN CASE THAT THE VIOLATOR FAILS
TO SURRENDER DRIVER'S LICENSE.**

WHEREAS, the Los Baños Traffic Management Office (LBTMO) has the legal personality to enforce all enacted ordinances regarding traffic violations;

WHEREAS, there is no existing ordinance giving legal personality to LBTMO to impound vehicle in every violation of each of the respective traffic ordinances in Los Baños in case that the violator fails to surrender driver's license;

WHEREAS, it is the predicament of all LBTMO traffic enforcers and personnel that they are constraint to impound vehicle in every violation of each of the respective municipal ordinances in case the violator fails to surrender driver's license subsequent with the absence of a municipal ordinance giving the legal personality to confiscate licenses in the former cases;

WHEREAS, to address this predicament and to give legal personality to LBTMO to fully implement all ruling Municipal Ordinances regarding traffic violations, this Ordinance is hereby crafted;

NOW THEREFORE, on motion of Councilor Marlo PJ A. Alipon, duly seconded by Councilwoman Josephine S. Evangelista and Councilor Mike Dexter A. Concio, and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA in session assembled **THAT**:

SECTION 1. TITLE - An ordinance giving legal personality to LBTMO to impound motor vehicles in every violation of all Traffic Rules and Regulations provided in the respective municipal ordinances, in case that the violator fails to surrender driver's license.

SECTION 2. GENERAL PROVISIONS - This Ordinance gives legal authority to all LBTMO traffic enforcers to impound vehicles in every violation of each of the respective Municipal Ordinances regarding traffic violations in case that the violator fails to surrender driver's license.


SECTION 3. REPEALING CLAUSE - All other provisions entailed in other Municipal Ordinances which are inconsistent with the provisions of this ordinance shall be repealed and amended accordingly.


SECTION 4. SEPARABILITY CLAUSE - If any of the provisions entailed in this Ordinance is found to be inconsistent with any other National Law or Constitution, all other provisions shall be valid provided that it will still effect legislation.

SECTION 5. EFFECTIVITY - This ordinance shall take effect immediately upon final approval of local government authorities, as specified under Book 1, Title Two Chapter 3 of RA 7160.



