ORDINANCE NO. 2020-1948

AN ORDINANCE PROHIBITING THE TRANSPORT OR HAULING OUT OF THE MUNICIPALITY, OF CONSTRUCTION OR EXCAVATION DEBRIS THAT MAY BE USED AS BACKFILL MATERIALS, FROM ALL PRIVATE AND PUBLIC INFRASTRUCTURE WORKS WITHIN THE VICINITY OF LOS BANOS.

WHEREAS, Republic Act 7160, otherwise known as the Local Government Code of 1991, empowers the municipal government to regulate infrastructure works within the locality and ensure that its natural resources are efficiently used, properly conserved and protected;

WHEREAS, the recent years has displayed a steady increase in the number of infrastructure and construction projects within the vicinity of Los Baños, both from government institutions, private entities and business sector;

WHEREAS, most of these projects has voluminous construction debris resulting from demolition and excavation works, and that this debris are often transferred, dumped, sold or exchanged by contractors to other construction sites in other cities and municipalities;

WHEREAS, these materials may be used as backfill materials needed for local government infrastructure and construction projects;

NOW THEREFORE, upon the motion of Councilor Janos S. Lapiz, which was duly seconded by Councilor Cris Dayril B. Bagnes and approved by all councilors present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA in session assembled **THAT:**

SECTION 1. GENERAL PROVISIONS

- (a) All construction and excavation debris from government, private or business establishments' infrastructure works within the vicinity of Los Baños that may be classified or used as Backfill Materials, are prohibited from being transported or hauled outside the boundaries of the municipality, unless otherwise permitted through a written consent or permit issued by the municipal government of Los Baños.
- (b) If the construction and excavation debris will not be used for other purposes by concerned stakeholders, the Municipal Government shall provide and determine the necessary space or area where the debris can be properly dumped.

SECTION 2. PENALTY

All violations of this ordinance shall be penalized as follows:

- 1st Offense – Confiscation of materials and a fine of One Thousand Five Hundred Pesos (P1,500.00) per truckload
- 2nd Offense – Confiscation of materials, impounding of vehicle and a fine of Two Thousand Pesos (P2,000.00) per truckload
- 3rd Offense – Confiscation of materials, impounding of vehicle, revocation of building permit and a fine of Two Thousand Five Hundred Pesos (P2,500.00) per truckload


SECTION 3. REPEALING CLAUSE – All previous ordinances contrary to or inconsistent with this Ordinance shall be deemed repealed or modified accordingly.


SECTION 4. SEPARABILITY CLAUSE – If any part of this ordinance is declared unconstitutional or unlawful, such declaration shall not affect the enforceability of the remaining provision of this Ordinance.


SECTION 5. EFFECTIVITY - This ordinance shall take effect immediately upon final approval of local government authorities, as specified under Book 1, Title Two Chapter 3 of RA 7160.
