SEVEN MILLION SIX HUNDRED SIXTY THOUSAND PESOS (P7,660,000.00).**

**WHEREAS**, the Annual Budget of Barangay Maahas, Los Baños, Laguna was studied and reviewed by the Local Finance Committee pursuant to the provisions set forth by R.A. 7160 otherwise known as the Local Government Code;

**NOW THEREFORE**, on motion of Councilor Geronimo A. Ciceron duly seconded by Councilor Miko C. Pelegrina, and concurred by all other members present;

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA**, in session assembled, THAT:

**SECTION 1.** SHORT TITLE – This ordinance shall be known as an ordinance approving the 2020 Annual Budget of Barangay Maahas, Los Baños, Laguna in the amount of Seven Million Six Hundred Sixty Thousand Pesos (P7,660,000.00).


**SECTION 2.** COVERAGE - This ordinance covers the 2020 Annual Budget of Barangay Maahas.

**SECTION 3.** EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.




