**ORDINANCE APPROVING THE BARANGAY ANNUAL BUDGET OF BARANGAY
MAYONDON, LOS BAÑOS, LAGUNA FOR THE YEAR 2020 IN THE AMOUNT OF
FOURTEEN MILLION FOUR HUNDRED THOUSAND PESOS ONLY
(P14,400,000.00).**

WHEREAS, Barangay Mayondon, Los Baños, Laguna has prepared and submitted their 2020 Annual Budget for approval by the Sangguniang Bayan;

WHEREAS, the said Annual Budget for the year 2020 of Barangay Mayondon, was supported by a Resolution and an ordinance;

WHEREAS, the Annual Budget of Barangay Mayondon with the corresponding amount, as stated above, has been certified by the Barangay Treasurer and the Local Finance Committee;

WHEREAS, the budget of Barangay Mayondon has been appropriated for expenditures for personal services, maintenance and other operating expenses and non-office expenditures, other services, etc., the details of which are contained in their Annual Budget Proposal;

WHEREAS, the correctness of the actual income for the last calendar year, for reasonable probability of collection of the estimated income for the current year, the Budget Year 2020 based on present conditions and subsisting tax ordinance had been certified by the Barangay Treasurer and the Local Finance Committee;

WHEREAS, the Annual Budget of Barangay Mayondon, Los Baños, Laguna was studied and reviewed by the Local Finance Committee pursuant to the provisions set forth by R.A. 7160 otherwise known as the Local Government Code;

NOW THEREFORE, on motion of Councilor Geronimo A. Ciceron duly seconded by Councilor Miko C. Pelegrina, and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


SECTION 1. SHORT TITLE – This ordinance shall be known as an ordinance approving the Annual Budget of Barangay Mayondon, Los Baños, Laguna for the year 2020 in the amount of Fourteen Million Four Hundred Thousand Pesos Only (P14,400,000.00).

SECTION 2. COVERAGE - This ordinance covers the 2020 Annual Budget of Barangay Mayondon.


SECTION 3. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


