BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:



SECTION 2. COVERAGE - This ordinance covers the 2020 Annual Budget of Barangay Lalakay.


SECTION 3. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.
