**AN ORDINANCE CREATING THE POSITION OF SOCIAL WELFARE ASSISTANT
WITH SALARY GRADE 8 AT THE MUNICIPAL SOCIAL WELFARE AND
DEVELOPMENT OFFICE.**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS,
LAGUNA, in session assembled, THAT:**

SECTION 1. Civil Service Commission (CSC) basic qualification standards are as follows:

EDUCATION : Completion of two years in college
EXPERIENCE : 1 year of relevant experience
TRAINING : 4 hours of relevant training
ELIGIBILITY : Career Service (Sub-professional) /
First Level Eligibility

SECTION 2. The duties and responsibilities shall be as follows:


- a. Provides assistance in case management;
- b. Assists and support clients and their families;
- c. Be a part of the rehabilitation team in case management of clients;
- d. Escorts clients during referral and court hearing;
- e. Assists MSWDO in organizing and conducting activities of clients;
- f. Records and documents clients' activities and submits the same to the social worker;
- g. Performs other duties that may be assigned from time to time.

SECTION 3. The source of funds shall be taken from the Annual Budget of CY 2020.


SECTION 4. This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


