ORDINANCE NO. 2020-1971

**AN ORDINANCE AUTHORIZING THE LOCAL CHIEF EXECUTIVE TO ENFORCE
MEASURES SUCH AS QUARANTINES, SUSPENSION OF CLASSES, WORK AND
PUBLIC GATHERINGS, AND TEMPORARY CONVERSION OF BUILDINGS OR
AREAS INTO ISOLATION OR HEALTH TREATMENT FACILITIES / AREAS
DURING DISEASE OUTBREAK SITUATIONS.**

WHEREAS, Section 16 of Republic Act 7160 provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, the local government unit is expressly mandated to be in-charged with the promotion of health and safety within their respective jurisdiction;

WHEREAS, the local government unit is mandated to take the lead in the prevention, mitigation, preparedness for and containment of the 2019 Novel Corona Virus Acute Respiratory Disease (nCoV ARD) and other Emerging Infectious Diseases (EID) at the local level;

WHEREAS, the Local Chief Executive, being the head of the local crisis management committee, is mandated to enforce measures to prevent, mitigate and contain infectious disease outbreaks in the community;

NOW THEREFORE, on motion of Councilor Geronimo A. Ciceron duly seconded by Councilor Marlo PJ A. Alipon and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. SHORT TITLE – This ordinance shall be known as an ordinance authorizing the Local Chief Executive to enforce measures such as quarantines, suspension, of classes, work and public gatherings and temporary conversion of buildings or areas into isolation or health treatment facilities / areas during disease outbreak situations.

SECTION 2. GENERAL PROVISIONS - This ordinance authorizes the Local Chief Executive to enforce measures during disease outbreak situations such as but not limited to the following:


- a. quarantines
- b. suspension of classes
- c. suspension of work
- d. suspension of public gatherings
- e. temporary conversion of buildings or areas into isolation or health treatment facilities / areas

SECTION 3. REPEALING CLAUSE – All other provisions entailed in other Municipal Ordinances which are inconsistent with the provision of this ordinance shall be repealed and amended accordingly.


SECTION 4. EFFECTIVITY - This ordinance shall take effect immediately upon approval.


