ORDINANCE NO. 2020-1982

ORDINANCE AMENDING SECTION 3 SUBSECTIONS (a) and (b) OF ORDINANCE NO. 2010-995, AN ORDINANCE CREATING THE POSITION OF MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICER WITH COMPENSATION AT SALARY GRADE 24 (SG-24) TO HEAD THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE WHICH IS UPGRADED FROM A UNIT TO A DEPARTMENT OF THE MUNICIPAL GOVERNMENT OF LOS BAÑOS AND APPROPRIATING FUNDS FOR THE PURPOSE.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1.** Section 3. QUALIFICATIONS – No person shall be appointed Municipal Social Welfare and Development Officer unless he /she fulfills the following qualification requirements as prescribed by the Local Government Code of 1991 and by the Civil Service Commission policies, rules and regulations:
- a. Education: Must have a Masteral Degree preferably in sociology or any other degree relevant to the job.
 - b. Experience: 4 years in position/s involving management and supervision.

c. Training: At least 24 hours in training in management and supervision;

d. Eligibility: R.A. 1080 (Social Worker)

Shall now be read as follows:

Section 3. QUALIFICATIONS – No person shall be appointed **Municipal Social Welfare and Development Officer** unless he /she fulfills the following qualification requirements as prescribed by the **Local Government Code of 1991** and by the **Civil Service Commission policies, rules and regulations**:

a. Education: **Must have a Bachelor’s Degree preferably in sociology or any other degree relevant to the job.**

b. Experience: **3 years in position/s involving the social work and management and supervision.**

c. Training: **At least 24 hours in training in management and supervision;**

d. Eligibility: **R.A. 1080 (Social Worker)**

SECTION 2. SEPARABILITY CLAUSE. If any provisions of this ordinance is declared unconstitutional or illegal, the same shall not affect the validity and effectivity of other provisions not affected thereby.

SECTION 3. REPEALABILITY CLAUSE. Any issuances, rules, and regulations and implementing guidelines and other ordinances which are inconsistent or contrary to this ordinance shall be deemed repealed, amended or modified accordingly.

SECTION 4. EFFECTIVITY. This ordinance shall be in force and effect upon approval.
