BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:


- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Maahas, Los Baños, Laguna amounting to Seven Hundred Thousand Pesos (Php 700,000.00) for Fiscal Year 2020.
- SECTION 2. COVERAGE** – The amount of Seven Hundred Thousand Pesos (Php 700,000.00) of Barangay Maahas, Los Baños, Laguna shall cover the expenses for MOOE: Purchase of 1 unit Ambulance.




