ORDINANCE NO. 2020-1991

AN ORDINANCE AMENDING SECTION 1 AND 2 OF ORDINANCE NO. 2017-1621: "AN ORDINANCE ESTABLISHING THE ORGANIC AGRICULTURAL TRADING POST OF LOS BAÑOS, LAGUNA."

WHEREAS, Republic Act 8435 defined as Agriculture and Fisheries Modernization Act of 1997, prescribing urgent related measures to modernize the agriculture and fisheries sectors of the country in order to enhance their profitability, and prepare said sectors for the challenges of globalization through an adequate, focused and rational delivery of necessary support services, appropriating funds therefore and for other purposes;

WHEREAS, the same Act also provided for the adoption of the market approach in assisting the agriculture and fisheries sectors while recognizing the contribution of said sectors to food security, environmental protection, and balanced urban and rural development, without neglecting the welfare of the consumers, especially the lower income groups;

WHEREAS, Section 1 and 2 of Ordinance No. 2017-1621 limits the selling / marketing of agricultural products to organic produce only thereby other agricultural products such as, but not limited to rice, aster, aquaculture products, raw meat products, and agricultural inputs particularly vermicast / compost, ameliorants and concoctions produced by Los Baños farmers are not given equal opportunity to market and access to government services.

NOW THEREFORE, on motion of Councilor Cris Dayril B. Bagnes duly seconded by Councilor Miko C. Pelegrina and concurred by all other members present;

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance establishing the Organic Agricultural Product Trading Post of Los Baños, Laguna.

Shall now be read as follows:

TITLE : Ordinance establishing the Agricultural Product Trading Post of Los Baños, Laguna

SECTION 2. OPERATION - The Local Chief Executive shall cause the issuance of an implementing guidelines for the operations of the Organic Agricultural Trading Post

Shall now be read as follows:

OPERATION : The Local Chief Executive shall cause the issuance of an implementing guidelines for the operation of the Agricultural Product Trading Post.

SECTION 3. MONITORING AND EVALUATION. The Local Chief Executive through the Office of the Municipal Agriculturist (OMA) shall conduct regular monitoring of the facility.

SECTION 4. FUNDING. The source of funds for the agricultural product trading post operations shall be taken from the available funds subject to existing laws, rules, and regulations.


SECTION 5. SEPARABILITY CLAUSE. If any part of this ordinance is declared unconstitutional or unlawful, such declaration shall not affect the other parts or sections hereof.

SECTION 6. REPEALING CLAUSE. All previous ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.


SECTION 7. EFFECTIVITY. This ordinance shall take force and effect upon approval.
