ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY BAYBAYIN, LOS BAÑOS, LAGUNA IN THE AMOUNT OF ONE HUNDRED NINETY-FIVE THOUSAND SEVEN HUNDRED FORTY-FOUR PESOS ONLY (Php 195,744.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of Barangay Baybayin, Los Baños, Laguna in the amount of One Hundred Ninety-Five Thousand Seven Hundred Forty-Four Pesos Only (Php 195,744.00) For Fiscal Year 2020.

SECTION 2. COVERAGE – The amount of One Hundred Ninety-Five Thousand Seven Hundred Forty-Four Pesos (Php 195,744.00) of Barangay Babayin, Los Baños, Laguna shall cover the expenses for MOOE under BDRRMF: Damayan sa Kapwa Kontra Covid 2019.


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


