ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY LALAKAY, LOS BAÑOS, LAGUNA IN THE AMOUNT OF TWO HUNDRED NINETY-EIGHT THOUSAND FOUR HUNDRED PESOS ONLY (Php 298,400.00) FOR FISCAL YEAR 2020.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Lalakay, Los Baños, Laguna in the amount of Two Hundred Ninety-Eight Thousand Four Hundred Pesos Only (Php 298,400.00) for fiscal year 2020.
- SECTION 2. COVERAGE** – The amount of Two Hundred Ninety-Eight Thousand Pesos (Php 298,400.00) of Barangay Lalakay, Los Baños, Laguna shall cover the expenses for MOOE under BDRRMF: Damayan sa Kapwa Kontra Covid 2019.


SECTION 3. SOURCE OF FUNDS – The amount of Two Hundred Ninety-Eight Thousand Four Hundred Pesos (Php 298,400.00) of Barangay Lalakay, Los Baños, Laguna shall be sourced from the 70% of continuing Barangay Disaster Risk Reduction Management Fund (BDRRMF) prior year 2015-2019.

SECTION 4. CERTIFICATION OF BUDGETARY ALLOCATION – The statement of fund actually available has been certified correct by the Barangay Treasurer based on year 2019 and the Municipal Accountant in accordance with the provision of Section 474 (b-4) of R. A. 7160;


SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


