**ORDINANCE APPROVING THE SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY MALINTA, LOS BAÑOS, LAGUNA IN THE AMOUNT OF THREE HUNDRED TWENTY-FOUR THOUSAND PESOS ONLY (Php 324,000.00) FOR FISCAL YEAR 2020.**

**BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF LOS BAÑOS, LAGUNA, in session assembled, THAT:**

- SECTION 1. TITLE** – Ordinance approving the Supplemental Budget No. 1 of Barangay Malinta, Los Baños, Laguna in the amount of Three Hundred Twenty-Four Thousand Pesos Only (Php 324,000.00) for fiscal year 2020.
- SECTION 2. COVERAGE** – The amount of Three Hundred Twenty-Four Thousand Pesos (Php 324,000.00) of Barangay Malinta, Los Baños, Laguna shall cover the expenses for MOOE under BDRRMF: Damayan sa Kapwa Kontra Covid 2019.

**SECTION 3. SOURCE OF FUNDS** – The amount of Three Hundred Twenty-Four Thousand Pesos (Php 324,000.00) of Barangay Malinta, Los Baños, Laguna shall be sourced from the 70% of Barangay Disaster Risk Reduction Management Fund (BDRRMF) prior year 2014-2019.



**SECTION 5. EFFECTIVITY** – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.




