SECTION 1. TITLE – Ordinance approving the Supplemental Budget No. 1 of
Barangay Mayondon, Los Baños, Laguna in the amount of Three
Hundred Ten Thousand Pesos Only (Php 310,000.00) for fiscal year
2020.

SECTION 2. COVERAGE – The amount of Three Hundred Ten Thousand Pesos
(Php 310,000.00) of Barangay Mayondon, Los Baños, Laguna shall cover

Covid 2019.




SECTION 5. EFFECTIVITY – This ordinance shall take force and effect upon approval subject to all existing auditing rules and regulations.


